PLAN SERVICES AGREEMENT

This Plan Services Agreement ("Agreement") is made between the employer or its authorized representative signing below as the Employer ("Employer") and Edward D. Jones & Co., L.P. ("Edward Jones") (together referred to as the "Parties"). This Agreement is part of the Edward Jones Account Agreement ("Account Agreement"), including the binding arbitration provision.

GENERAL PROVISIONS

Employer has opened a brokerage account with Edward Jones ("Account"). Employer agrees that services Edward Jones provides are not fiduciary services but are intended only to assist Employer in providing benefits or defraying reasonable expenses of administering the plan, arrangement or program that is sponsored by the Employer on behalf of its employees and/or their beneficiaries ("Plan"). Those services may, but will not necessarily, include providing Employer:

- * Information to assist it in selecting a suitable investment product to hold investments of the Plan
- * Assistance in transferring assets from another financial institution to Edward Jones or the issuer of a Product (as defined below)
- * Assessment tools to enable Employer and other plan fiduciaries to determine the Plan's investment objectives
- * Sample investment policies and information about how to establish an investment policy
- * Information about how to diversify Plan investments and evaluate asset allocation models
- * Educational services to Plan participants and their beneficiaries that include Plan information, general financial and investment information and financial models.

Except as otherwise expressly provided in the Account Agreement, Edward Jones shall not be responsible for the provision of any services to the Plan including, but not limited to, preparation or transmittal of any notices to participants, participant-level recordkeeping, actuarial services, calculation of contributions, collection of contributions, preparation or filing Form 5500, tax withholding and reporting, and performance of any non-discrimination or other testing.

Edward Jones receives compensation for services rendered under this Agreement as well as compensation arising from Products. Employer has reviewed the compensation arrangements between Edward Jones and applicable Product issuers, including disclosures made by Edward Jones and such Product issuers, and agrees that the compensation is reasonable. Only the Employer or other authorized fiduciaries of the Plan or, in the case of a participant-directed plan, participants, may exercise any discretion over Plan assets and only they may make decisions regarding investments of the Plan, including investments in a Product. Edward Jones does not exercise any discretionary authority over Plan assets. Any service Edward Jones provides regarding an Account is intended merely to assist the decision makers of the Plan. It is not a primary basis of investment decisions concerning Plan assets and is not investment advice as that term is defined by the Employee Retirement Income Security Act of 1974, the Investment Advisers Act, the Internal Revenue Code or other law. Edward Jones is not a plan fiduciary.

ASSETS NOT HELD BY EDWARD JONES

Employer understands and agrees that Employer might select a product that is not issued by or held by Edward Jones ("Product"), information about which may be included by Edward Jones in reports of the Account. All terms and conditions of a Product are controlled by agreements Employer and the issuer of the Product may enter into regarding the Product and Edward Jones is not a party to such agreements.

Employer further understands and agrees that information provided by Edward Jones concerning any Product is solely based upon information provided by the issuer and Edward Jones is not responsible for the completeness or accuracy of such information.
